

REGISTRATION PRINCIPLES FOR INTERNATIONAL STUDENTS WHO GAIN REGISTRATION RIGHT TO İZMİR KÂTİP ÇELEBİ UNIVERSITY IN 2015-2016 ACADEMIC YEAR

It is kindly requested all international students to take into consideration the important points stated below:

- First visit International Office with necessary documents for registration on the dates specified.
- Get necessary controls done by International Relations Office (The documents will thereafter be sent to your faculty for registration)
- The registration date for the candidates gaining the registration right to İzmir Kâtip Çelebi University: **17-26 August 2015**
- The registration date for the Substitute Candidates: **27 August - 4 September 2015**
- In order to be registered, candidates should meet one of the requirements stated below. (See Section A)
- In case that selected candidates are not registered, substitute candidates can register to the departments having vacant quota based on the list of substitute candidates, which will be revealed on 27th of August on www.ikc.edu.tr)

A) Special Conditions To Be Provided by the Candidates for the Registration

Registration of the candidates

- a) who are foreign nationals,
- b) who are Turkish citizens by birth, but acquired permission to leave Turkish citizenship and those who certify that they have a certificate of use of recognition of rights given to the minors registered on the declaration of alienage entitled by Turkish Citizenship Law, (Due to the provision in Article 7 of 5901 numbered Turkish Citizenship Law “ (1) A child born within marriage to a mother or father with Turkish citizenship either within or outside Turkey is a Turkish citizen.”, applicants for foreign student admissions should examine the Turkish Citizenship laws),
- c) who are foreign nationals by birth and acquired Turkish nationality / applicants who have dual citizenship in this way,
- d) who are Turkish citizens but had all of their secondary education in a country other than the TRNC (Turkish Republic of Northern Cyprus) (including those who had all of their secondary education at a Turkish school other than in the TRNC),
- e) holding TRNC citizenship who reside in the TRNC, have completed their secondary education in the TRNC and hold GCE-AL exam results and also those educated at colleges and high schools in a different country between 2005-2010 and possess GCE-AL exam results,

shall be made on condition the applicant is studying the final year of her/his secondary education (high school) or has already graduated.

B) Documents for Registration

- 1) The original secondary school diploma with a notarized Turkish translation from a Notary or Turkish Embassy/Consulate abroad,
- 2) Diploma Equivalency Certificate given by the Turkish Ministry of Education
- 3) A notarized copy of the applicant's passport,
- 4) A copy of the notarized Residence Permit (it should be submitted during the registration or in 30 weekdays)
- 5) For those who have dual citizenship by gaining a foreign citizenship by birth and later became also a T.C. citizen, "Vukuatlı Nüfus Kayıt Örneği"
- 6) For male Turkish citizens, declaration of military service.
- 7) A copy of the notarized Residence Permit
- 8) Transcripts, showing the names of courses, number of hours per week and grades received for the courses, approved by the principle of the applicant's high school with a notarized Turkish translation approved by a Notary or Turkish Embassy/Consulate abroad,
- 9) Bank slip (receipt) of tuition fee payment
- 10) 6 photographs,
- 11) The document showing the result of one of the exams, which is stated in the application guide.
- 12) If exists, a Foreign Language Certificate approved by YÖK (The Council of Higher Education). Other language certificates will not be accepted
- 13) If exists, Turkish Proficiency Certificate which will be approved by İzmir Katip Çelebi University Turkish Teaching, Application and Research Center (İKÇU TOMER).

C) Acceptance Letters

Acceptance Letters of candidates placing in one of the programmes as a selected or substitute candidates will be sent to the students' e-mails stated in their applications. Acceptance Letter will be signed in electronic document management system electronically and confirmation will be made with the code stated under document.

Candidates can make a visa application with their Acceptance Letters which are sent to their e-mails. Candidates who cannot reach their Acceptance Letters in their e-mails should also check junk e-mail. If Acceptance Letter has still not seen, please contact the International Office.

D) Tuition Fees for International Students

As The Decision of Council of Ministers, which will determine the tuition fees of 2015-2016 Academic Year have not been published in the official gazette yet, the candidates will pay the amounts determined by the University Administrative Committee. If there will be a difference between the charged amount and the amounts to be determined by the aforementioned Decision of the Council of Ministers, it will be reflected to the tuition fees later.

The candidates' name-surname, the Foreign National Identity Number, and the departments they have been placed should be written on the Bank slip (receipt) of tuition fee payment.

G) The Students Who Won't Pay Tuition Fee In The Case Of Providing Evidence For The Situations Stated Below

- 1- Syrian citizens who are placed in a higher education institution according to the principals determined by the Higher Education Council
- 2- The students who have Blue Card
- 3- The students being Turkish Republic citizens and completed their secondary education in a foreign country except TRNC
- 4- The students completed their secondary education in a Turkish School in a foreign country except TRNC

H) 2015-2016 Academic Year Foreign Language Proficiency Exam

All international students who gain registration right to İzmir Kâtip Çelebi University in 2015-2016 academic year should take Turkish or foreign language proficiency exam based on their departments' language of education.

There will be only foreign language proficiency exam for the departments which give education in foreign language.

There will be both Turkish and foreign language proficiency exam for the departments which partially give education in foreign language.

There will be Turkish exam for the departments which give education in Turkish.

- Turkish Proficiency Exam:** 18 September 2015
English Proficiency Exam: 15-16 September 2015
Arabic Proficiency Exam: 15-16 September 2015
